

Butterfield Reduces Rates

Hamilton, Bermuda –September 18, 2024: The Bank of N.T. Butterfield & Son Limited (“Butterfield”) announced that it is reducing its base interest rates on loans and mortgages by a quarter of a percentage point (0.25%).

The change in base rates applies to Bermuda dollar residential mortgages, consumer loans, corporate loans and USD loans. The rate reduction on loans takes effect September 23, 2024. The rate reduction for existing Bermuda residential mortgages is effective 90 days later.
