<b>Acceptance</b>	Entry into the promotion constitutes acceptance of these terms and conditions ("Terms"). In case of any inconsistency between these Terms and any other published material, these Terms prevail.
<b>Initiative Period</b>	The Promotion will take place during the following period:  Start: 10 <sup>th</sup> of March 2025, 12:01AM, Bermuda time  End: 11 <sup>th</sup> of July 2025, 11:59 PM, Bermuda time  No promotions will be accepted outside this period.
<b>Eligibility guidelines</b>	Only the following may participate: (i) Companies who hold Membership with Mailboxes and are incorporated in Bermuda, (ii) natural persons, who are legal residents of Bermuda, and eighteen (18) years of age or older. Participants must be a Member of Mailboxes Unlimited and have a valid Butterfield Business Credit/Debit Mastercard on-file at the time an invoice is billed to the client. Participants who do not have a Butterfield Business Debit or Credit Mastercard, issued by Butterfield Bank, on file at the time of billing will not be eligible to receive the discount.  To be eligible to participate in the promotion, a customer's account must be in good standing and their personal contact information, including address, email address, phone number, and payment information, must be current (both at the time of entry and at each individual invoice billing cycle).
<b>Details of discount</b>	Mailboxes "Company Members" are eligible to receive a discount on the cost of shipping, and only shipping, for each shipment's invoice throughout the entirety of the campaign. <b>Foregone discounts</b>	If a member does not have a Butterfield Business Credit/Debit Mastercard on-file at the time of billing, the member will be ineligible to receive the discount. In certain circumstances, Mailboxes Management reserves the right to apply a discount to the invoice when a member pays with eligible cards at the time of collection (e.g., if is the Member's first shipment and payment processing was

	not successful due to a missing payment method; Mailboxes may use the opportunity to educate clients.
<b>Unauthorized discounts</b>	In the event a Mailboxes Member receives an unauthorized shipping discount (i.e., discounted without meeting these Terms and Conditions, Mailboxes may require the Member to repay the discount amount in full prior to shipping any future shipments).
<b>Resolution</b>	Mailboxes expressly reserves the right to resolve any discrepancies, disputes or otherwise unforeseen circumstances as it deems fit and Mailboxes decision will be final and binding upon every person who participates. No correspondence will be entered into. Mailboxes expressly reserves the right to change or alter these Terms at any time.
<b>Suspected Tampering of Promotion</b>	If this promotion is not capable of running as planned due to any reason, including unauthorized intervention, fraud, or any other causes beyond the control of Mailboxes, which corrupt or affect the administration, security, fairness, integrity or proper conduct of this promotion, Mailboxes reserves the right (subject to any applicable law) in its sole discretion to cancel the promotion or to disqualify any individual who Mailboxes reasonably suspects has tampered with the discount process.
<b>Warranties</b>	To the greatest extent permitted by law, Mailboxes excludes all warranties, representations or guarantees (“Warranties”) regarding the promotion, including any Warranties which may have been made in the course of advertising or promoting the Promotion.
