MasterRental Insurance pays for covered damages to rental vehicles up to US\$50,000 when you use Butterfield's Business Debit Mastercard to pay for the entire rental transaction. Mastercard Cardholders and those designated in auto rental contracts as authorised drivers are covered. The Cardholder must rent the car in his or her own name and decline the collision/loss damage waiver offered by the car rental company. Covered damages include:

- Physical damages of the rental vehicle due to collision, theft, vandalism, and accidental fire, up to the actual cash value, subject to the maximum benefit amount provided.
- Reasonable and customary charges imposed by the rental car company for the period of time the car is being repaired ("Loss of Use" charges) that are substantiated by a Fleet Utilisation Log.
- Reasonable and customary towing charges to the nearest qualified repair facility imposed by the rental agency on a covered loss.

### ATM Protection

Mastercard provides coverage to Cardholders who are assaulted or robbed during or immediately after using an Automated Teller Machine to access their Account(s) using a Butterfield Business Debit Mastercard. In the event of death due to the assault, coverage may also be provided up to US\$3,600.

## Overview

Butterfield's Business Debit Mastercard is designed to meet the specific needs of small to medium-sized businesses where the company's accounts are managed by single or multiple signatories. It provides flexible daily limits on purchases and cash withdrawals. You can also request additional Cards for staff who have authority to purchase on behalf of your company. Note that these employees must be added to your Business Account as signatories.

Cards can be assigned a preset spending limit to help you keep business transactions under control.

## Worldwide Acceptance/Cash Advances

Accepted at over 28 million merchant locations and over 1 million ATMs worldwide, Mastercard is a trusted brand that provides you access to your funds anywhere, anytime.

MasterTravel provides coverage up to US\$250,000 against accidental death, dismemberment, or paralysis when travelling as a passenger by land, air, or sea on a licensed common carrier. Cardholders must purchase tickets using their Butterfield Business Debit Mastercard. Coverage is provided to Cardholders, their spouses, and unmarried dependent children under age 18—or up to age 25, if attending school as a full-time student—including stepchildren or legally adopted children. Spouses and dependent children do not need to be travelling with a Cardholder to be considered Insured Persons. In addition, through the Insured Journey Benefit programme, MasterTravel provides 24-hour coverage against accidental death for up to 60 days after disembarkation from a common carrier at the destination of a trip.

Mastercard Global Service™ provides unparalleled emergency customer service—anytime, anywhere, and in any language. Mastercard Global Service gives you access to the following services:
